## Terms & Conditions of Sale

The buyer accepts the terms and conditions set out below. In the event of the buyer's order containing special conditions, it is understood and agreed that such conditions are binding only so far as they are not at variance with these terms unless evidenced in writing and signed by a director of This company.

### Prices

All prices quoted include delivery within Oxfordshire and surrounding area unless otherwise stated. Prices for goods other than those quoted in writing will be those ruling at the date despatched and are subject to alteration without notice. All prices are subject to all applicable taxes.

### Delivery Charges

Our minimum delivered order value is £30.00. If any order is accepted below this it may be subject to an appropriate delivery charge.

### Date of Invoice/Tax Point & Payment Terms

This is ruled to be the date of despatch from this company's warehouse. It may not necessarily coincide with the date of delivery. Payment Terms are payment at the end of the month following date of invoice unless otherwise agreed in writing with a director of the company. The company WILL impose interest at 2% per month on seriously outstanding account balances.

### Return of Goods & Damaged Goods

When goods are returned as not being required, we reserve the right to levy a 15% administration charge together with any carriage costs charged to this company. No request for return will be considered for goods invoiced more than six weeks prior to the date of enquiry. When returning goods, the invoice number must be quoted before any credit can be raised. On no account will goods be collected without paperwork generated by our offices.

Any goods damaged in transit should be signed for as "DAMAGED". All deliveries should be checked immediately. In event of any loss or damage the company and carriers must be notified at once by telephone, and no later than 48 hours following delivery. Subsequently damages & shortages must be confirmed in writing.

### Title

The goods supplied are supplied by the seller to the purchaser who will act as trustees for the seller. The trustees shall hold the goods until all moneys due to the seller in respect of the goods have been paid. In the event of the purchaser failing to make payment in accordance with the terms of this contract or acting in anyway breach of the fiduciary capacity created by this clause or in the event of the purchaser becoming adjudged bankrupt or entering into any arrangement with his creditors or entering into liquidation, the seller shall be entitled to repossess the goods in whosever hands the same may be.
